## Looking Back and Looking Ahead...

Since 2020, the Maternal Health Hub Learning Community has grown to 300+ members, representing over 125 organizations, and met 22 times. The MHH website receives approximately 400 page views a month, and MHH twitter has almost 600 followers.

Thank You to the Learning Community, to our sub-contractors the National Birth Equity Collaborative, and to the Commonwealth Fund for supporting this work!

In January we surveyed the Learning Community to gather feedback on the following questions:

- What has been most valuable in terms of Maternal Health Hub Resources and Topics?
- What are the top challenges in addressing maternal mortality and morbidity?
- What Medicaid reforms are most critical to supporting the community-based maternity model?

The goal of survey was to identify potential focus areas for future work



### Maternal Health Hub Value

- Learning about promising practices in payment reform that support affordable access to midwives, birth centers, doulas, childbirth educators, community health workers, and expanded coverage
- Hearing from states, commercial payers, and providers about health equity efforts
- Having access to curated resources and research in a format that is easy to download and disseminate
- Learning about the role payers play in addressing the maternal mortality and morbidity crisis



## Current and Ongoing Challenges

- Flawed core care model based on management and pathology versus support, wellness, and addressing social and mental health needs
- Overall inadequate funding which leads to challenges in:
  - Securing sustainable reimbursement for comprehensive, community-based prenatal and postpartum care providers and settings
  - Making patient education on birthing options and patient-centered care widely available to empower birthing people to make informed choices
  - Lack of access to evidence-based models of care (midwifery, doula care, birth centers, mental health)
- Structural, institutional, and interpersonal racism and other forms of discrimination
- Lack of access to evidence-based care in clinical settings
- Roadblocks at the federal, state and institutional levels to reproductive justice
- Workforce Challenges: bias, pipeline, barriers to recruiting and training a diverse workforce



## Top Priorities for Leveraging Medicaid

- Appropriate/Parity Reimbursement that ensures adequate networks and access for birthing individuals
  - Licensed midwives
  - Doulas and perinatal community health workers
  - Facility fees for birth centers and resources for home birth
  - Certified childbirth educators
- Support for services that address social risk factors: food deserts, housing, transportation
- Continued leveraging of Medicaid MCO contracting
- Incentives that support adoption and integration of midwives and doulas; and measures that allow payment to be tied to such integration
- Reduced regulatory burdens for birth centers to contract with Medicaid
- Value-based maternity care models that move away from the fee-for-service model
